This refers to your license amendment request dated September 19, 2023. Please find enclosed Amendment No. 5 authorizing the removal of the location of use at the Arecibo Observatory.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
