## **NRC Seeks Input, Offers Hearing Opportunity on Oconee Station Subsequent License Renewal Draft Environmental Impact Statement**

The Nuclear Regulatory Commission is seeking public comment on its draft site-specific environmental impact statement – called an EIS – for Duke Energy Carolinas’ application proposing a second renewal of the licenses for the Oconee Nuclear Station in Seneca, South Carolina.

Duke is seeking a second, or subsequent, renewal of the plant’s licenses from 60 to 80 years. The licenses for the three Oconee reactors currently expire in February 2033 for Unit 1, October 2033 for Unit 2, and July 2034 for Unit 3.

The staff’s preliminary conclusion in the EIS is there are no adverse environmental impacts that would preclude the renewal of Oconee Station’s operating licenses for another 20 years. The draft EIS is open for comments for 45 days after publication of a Federal Register notice, anticipated Feb. 16.

The NRC staff will hold two public meetings on the draft EIS. The first [meeting](#) will be held Feb. 21 from 7-9 p.m. Eastern time at the Clemson University Conference Center, 230 Madren Center Drive in Clemson, South Carolina. The staff will also hold an open house from 6-7 p.m. Eastern time for informal discussions with the public. The second [meeting](#) will be a webinar from 1-3 p.m. Eastern time on Feb. 27. At both meetings, the staff will discuss the environmental review process and accept comments on the draft EIS.

The NRC is also providing an opportunity to request an adjudicatory hearing on new information presented in the draft EIS. Interested parties have 60 days from today’s Federal Register [notice](#) to file a hearing request.
