This refers to your license amendment request dated October 11, 2023. Please find enclosed Amendment No. 27 authorizing a new location of use and a new Authorized User, as well as correcting a spelling error for an existing authorized location of use. Consistent with 10 CFR 35.190(b) and your email dated December 11, 2023, Dr. Kunke's authorization has been expanded to include 10 CFR 35.100 in addition to the 10 CFR 35.200 authorization initially requested.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC.
