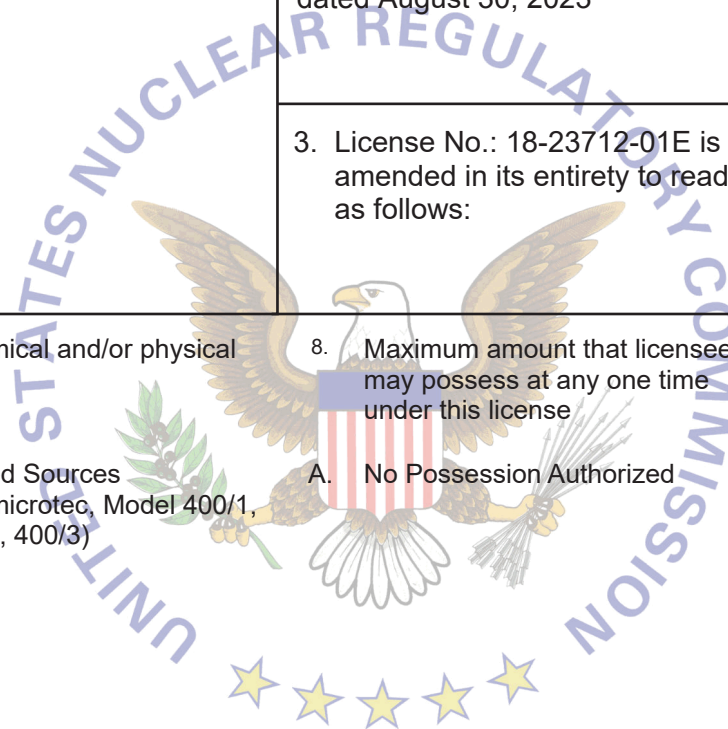


MATERIALS LICENSE

This license shall be deemed to contain the conditions specified in Section 183 of the Atomic Energy Act of 1954, as amended, and is subject to all applicable rules, regulations, and orders of the Nuclear Regulatory Commission now or hereafter in effect and to any conditions specified below.

CONDITIONS

10. The following self-luminous timepieces containing tritium designed and manufactured in accordance with NRC registration certificate No. NR-0446-D-103-E and No. NR-0446-D-104-E may be distributed according to this license provided the amount of tritium contained in each timepiece does not exceed the amount specified in the following table:
