This refers to your license amendment request dated September 22, 2023. Please find enclosed Amendment No. 54 changing the licensee name to Children's National Hospital. We have updated the change in administration in our internal Web Based Licensing (WBL) system.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
