The Commission is being asked to act on a Memorandum and Order addressing the Atomic Safety and Licensing Board's certified question in LBP-24-1. The certified question asks whether the staff's timing of the notice of opportunity for hearing is acceptable as it relates to the

environmental review for the subsequent license renewal of Turkey Point Nuclear Generating Units 3 and 4.
