This refers to your license amendment request dated October 24, 2023. Please find enclosed Amendment No. 18 authorizing Mark Perna M.S. as the Radiation Safety Officer and the removal of James Benjamin, M.D., as both the Radiation Safety Officer and Authorized User.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
