This refers to your license amendment request dated January 16, 2024. Please find enclosed Amendment No. 18 which (1) removes Dr. Michael Joseph Maroney, M.D., as an authorized user, (2) adds James Patrizi, M.D., as an authorized user, and (3) changes the Radiation Safety Officer to Mark Perna, M.S., DABR. Please note that the name of the licensee was updated to reflect your notice to the NRC in 2020 (see the original letters to the NRC under ADAMS Accession Nos. ML20098D573, ML20154K595, as well as the NRC's Request for Additional Information related to your 2024 amendment request at Accession No. ML24030A488 and your response at Accession No. ML24030A489). Finally, please note that your license has been updated to a landscape format.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
