If the Troxler 3216 gauge currently authorized in License Items 6-9 E, or if the Troxler Model 3401 and 3411B devices currently authorized in License Items 6-9 A-B, should be removed from the license, please provide final leak test records for these devices as well as records showing they have been appropriately transferred to another licensed entity.</p> <p>2.
