Dear Tribal Chairman Robert Blanchard:

The U.S. Nuclear Regulatory Commission (NRC) staff is issuing for public comment the draft environmental impact statement (DEIS), NUREG–1437, Supplement 26, Second Renewal, "Site-Specific Environmental Impact Statement for License Renewal of Nuclear Plants Regarding Subsequent License Renewal for Monticello Nuclear Generating Plant, Unit 1, Draft Report for Comment." Monticello Nuclear Generating Plant, Unit 1 (Monticello) is operated by Northern States Power Company (doing business as Xcel Energy) and is located in Wright County, Minnesota, on the southern bank of the Mississippi River. The NRC staff initiated consultation with your office regarding this project on March 13, 2023. In accordance with Title 36 of the Code of Federal Regulations (36 CFR) Section 800.8(c), the NRC staff has elected to use the National Environmental Policy Act of 1969, as amended, process to comply with its obligations under Section 106 of the National Historic Preservation Act of 1966, as amended.

The NRC staff has prepared a DEIS that evaluates the environmental impacts of the proposed action and alternatives of the proposed action (i.e., continued operation for a period of 20 years for Monticello). As discussed in the DEIS, the NRC staff's preliminary recommendation is that the adverse environmental impacts of the subsequent license renewal (SLR) are not so great that preserving the option for energy-planning decision-makers would be unreasonable. The NRC staff has concluded that the proposed action, SLR, would not adversely affect historic properties or historic and cultural resources.
