Dear Mr. Ramos:

This letter documents the results of an investigation initiated on October 22, 2021, by the U.S. Nuclear Regulatory Commission (NRC) Office of Investigations (OI), Region I, King of Prussia, Pennsylvania at a Mistras Group, LLC (Mistras) facility located in Trainer, Pennsylvania. The investigation, which was completed on October 19, 2022, and supplemented on May 9, 2023, evaluated whether Mistras employees engaged in deliberate misconduct by falsifying certificates of calibration for non-destructive test equipment that was used at nuclear power plants.

Based on the results of the OI investigation the NRC determined your actions were deliberate and that you violated the NRC's deliberate misconduct rule, 10 CFR 50.5(a)(2), which prohibits employees from deliberately submitting information to a licensee that the person submitting the information knew to be incomplete or inaccurate in some respect material to the NRC. Specifically, the NRC has concluded that you, as the former Mistras engineer, engaged in deliberate misconduct by falsifying certificates of calibration for non-destructive test equipment that was used at nuclear power plants. Additionally, your actions caused Mistras to be in violation of NRC requirements. A copy of the enforcement action to Mistras is included as an enclosure to this letter.

The OI investigation report was provided to the U.S. Department of Justice for potential criminal prosecution. On September 14, 2023, you signed a felony plea agreement that resulted in your conviction. Your sentence on January 25, 2024, included a 2-year ban from participating or being employed in NRC licensed activities.

In determining the appropriate sanction to be issued in this case, the NRC considered issuing an Order prohibiting your involvement in NRC-licensed activities as a result of your actions. However, after considering the criminal conviction which includes a 2-year ban from participating or being employed in NRC licensed activities, the NRC has concluded no further action is warranted.

You are not required to respond to this letter. However, should you choose to respond, your response should be sent to the U.S. Nuclear Regulatory Commission, ATTN: Director, Office of Enforcement, U.S. Nuclear Regulatory Commission, One White Flint North, 11555 Rockville Pike, Rockville, MD 20852-2738, with a copy to the Document Control Desk, Washington, DC 20555-0001 marked "Open by Addressee Only," within 30 days of the date of this letter.

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter, its enclosure(s), and your response, if you choose to provide one, will be made available electronically for public inspection in the NRC Public Document Room or from the NRC's Agencywide Documents Access and Management System (ADAMS), accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.
