This refers to your license amendment request dated February 6, 2024. Please find enclosed Amendment No. 36 authorizing the addition of two stress labs. In addition, this corrects the sealed source model number reflected under License Condition 6.D.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
