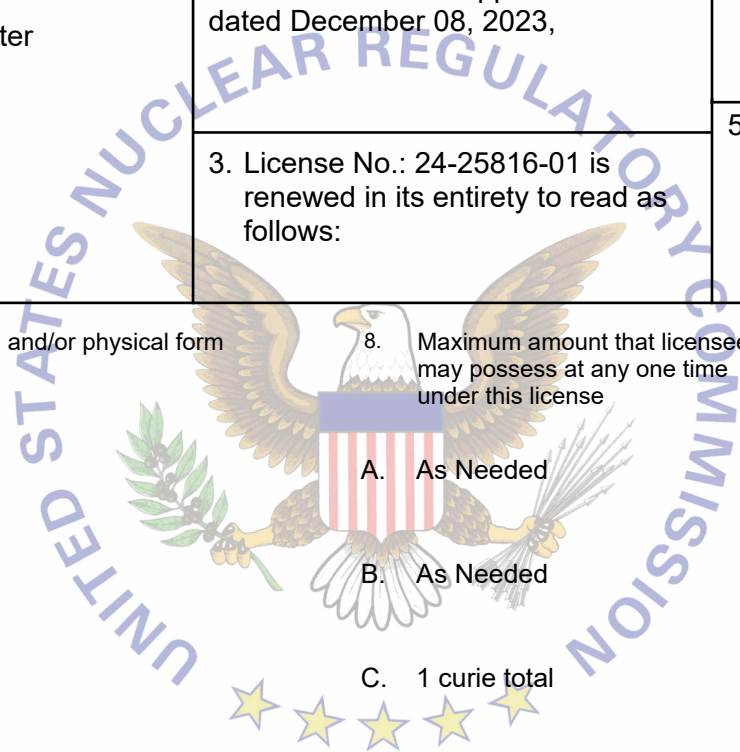


**MATERIALS LICENSE**
