Dear Tonya Osborne:

As the Cognizant Security Agency for your company's facility security clearance (FCL) under Title 10 of the *Code of Federal Regulations* (10 CFR), Part 95, the U.S. Nuclear Regulatory Commission (NRC) is responsible for maintaining current facility security information regarding your company.

By letter dated April 22, 2023 (ADAMS Accession No. ML24128A033) our licensee, American Centrifuge Operating, LLC (ACO) a subsidiary of Centrus Energy Corp informed us that it no longer has a need for your company to retain a FCL under 10 CFR Part 95. We understand you were notified by ACO; therefore, your company's non-possessing NRC FCL and Foreign Ownership, Control, or Influence determination have been terminated. As a result of the terminated NRC FCL the Facility Data and Approval Record in Unclassified Safeguards and Security Information Management System for facility code 8748 has also been terminated. Personnel clearances related to classified NRC work will be terminated by the Department of Energy at the request of ACO.
