Please find enclosed Amendment No. 6, terminating License No. 06-00819-05 as requested by your NRC Form 314 dated March 29, 2024. This termination is being issued in accordance with the requirements of the applicable NRC Termination Rule in 10 CFR 30.36. All facilities previously used for licensed activities may be released for unrestricted use. Additionally, due to the termination request, we are administratively closing the renewal request you submitted on February 14, 2024, under mail control 639822.

Based on the letter dated March 29, 2024, you informed us that you no longer need the requested action, and you are withdrawing the Financial Assurance action. Therefore, we have administratively closed your Financial Assurance under Mail Control No. 630893. Furthermore, based on the letter dated March 29, 2024, you informed us that you no longer need the requested action and you are withdrawing the renewal request. Therefore, we have administratively closed your license renewal request under Mail Control No. 639822.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(20).
