Dear Members of the Technical Specifications Task Force:

By letter dated April 22, 2024 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML24113A002), you submitted a request to the U.S. Nuclear Regulatory Commission (NRC) to incorporate Traveler TSTF-600, Revision 0, "Revise the Reactor Coolant System (RCS) Pressure Isolation Valve (PIV) Leakage Testing Frequency," into the standard technical specifications.

Section 170.21 of Title 10 of the *Code of Federal Regulations* requires that Travelers are subject to fees based on the full cost of the review. You did not request a fee waiver; therefore, NRC staff hours have been billed accordingly. The NRC staff estimates that the review will require approximately 300 staff hours including project management time.

The NRC staff has completed a preliminary review of your submission and determined it is sufficiently complete and appropriate to initiate a more comprehensive review. The review will generally follow the schedule below.
