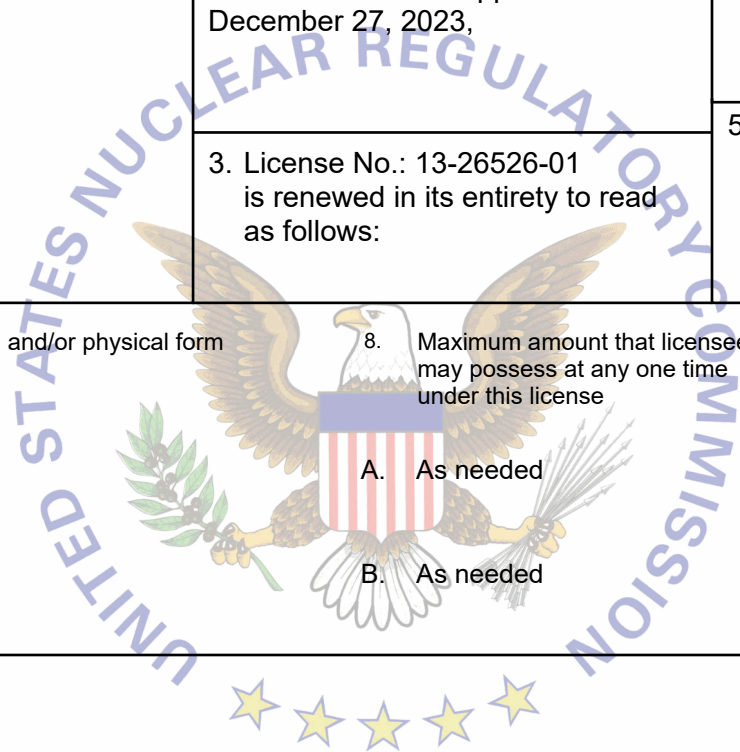


MATERIALS LICENSE

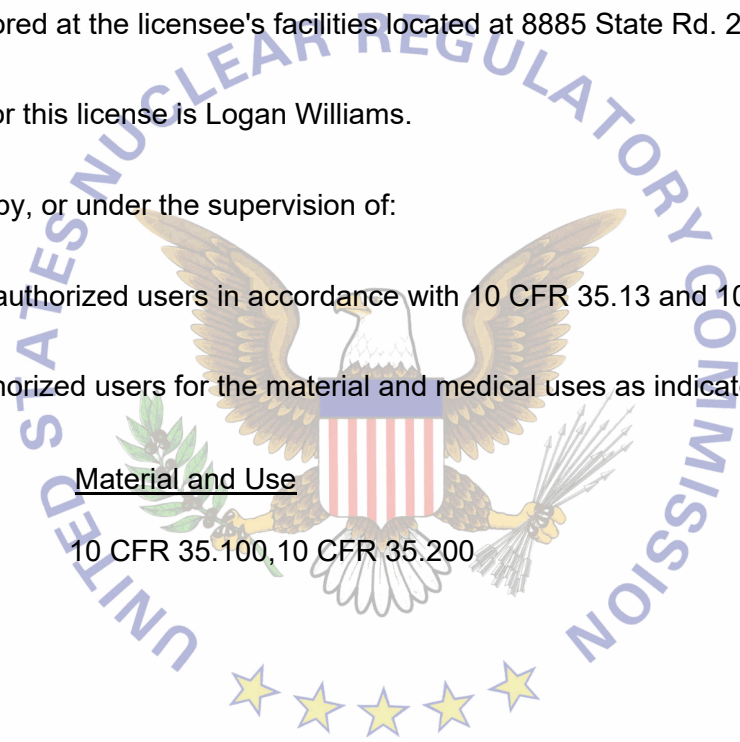
10. Licensed material shall be used or stored at the licensee's facilities located at 8885 State Rd. 237, Tell City, Indiana, 47586.
