Title: Pre-submittal meeting with Virginia Electric and Power Company (VEPCO) to discuss its proposed license amendment for Surry Power Station, Units 1 and 2.

Category: This is an Observation Meeting. This is a meeting in which attendees will have an opportunity to observe the NRC performing its regulatory function or discussing regulatory issues. Attendees will have an opportunity to ask questions of the NRC staff or make comments about the issues discussed following the business portion of the meeting; however, the NRC is not actively soliciting comments towards regulatory decisions at this meeting.

Purpose: The purpose of this meeting is for VEPCO to discuss its proposed amendments to Technical Specifications (TS) 3.7, "Instrumentation Systems," and TS 3.14, "Circulating and Service Water Systems," at Surry Power Station, Unit 1 and 2. The licensee proposes to extend the allowed outage times and use temporary equipment to complete maintenance and apply carbon fiber-reinforced polymer on the inside surface of service water system piping.
