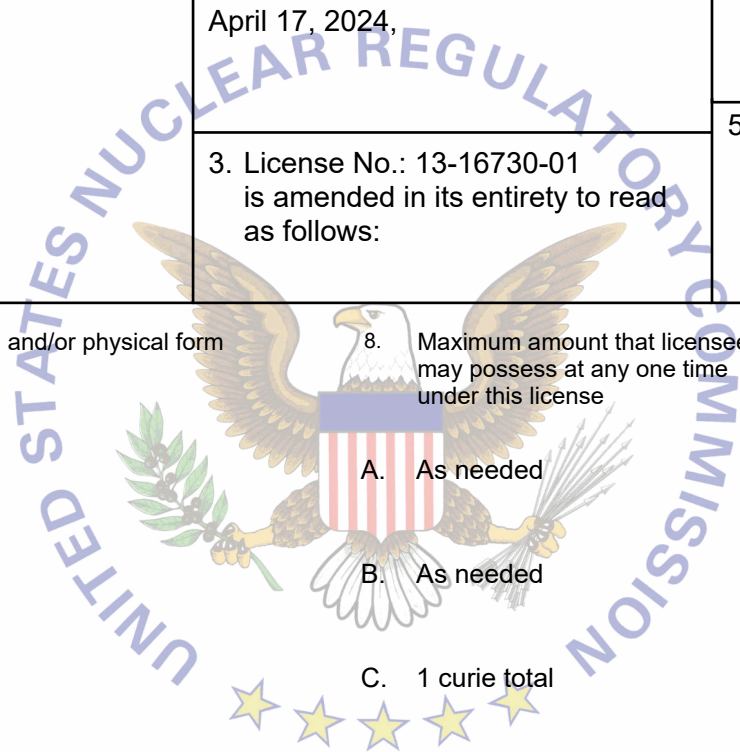


MATERIALS LICENSE
