Enclosed is Amendment No. 70 renewing your NRC Material License No. 45-25221-01MD in accordance with your request dated December 1, 2023.

Please note that the response dated June 7, 2024 did not provide disposal or survey records associated with the licensed material authorized in Item Nos. 6.N. – 6.O. As such, these materials were authorized on the license for possession only pending disposal. To fully remove these items from the license and to release the associated financial assurance instrument, please provide records demonstrating that licensed materials authorized in Item Nos. 6.N. – 6.O. were returned to the manufacturer in accordance with the documents provided to the NRC on May 12, 2017 [ML17136A184]. Additionally, please provide survey results demonstrating that associated remaining residual contamination is not present.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.
