Enclosed is Amendment No. 77 to your U.S. Nuclear Regulatory Commission (NRC) Materials License No. 21-04080-01 in accordance with your letter dated May 10, 2024.

This amendment includes the following changes in accordance with your request:

- removal of authorization for the Elekta, Inc. (formerly Nucletron) Model 105.999 High Dose Rate (HDR) Remote Afterloading Unit;
- removal of Nancy Andrews, M.D., Harold Kim, M.D., Kenneth J. Levin, M.D., and Amy Tobin, D.O., as Authorized Users;
- removal of Benjamin A. Catt, M.S., as an Authorized Medical Physicist; and
- release of the Interventional Radiology Room 1 to unrestricted use.

In your request, you identified that the yttrium-90 SIR-Spheres were never used in the Interventional Radiology Room 1.

Based on my review of your statement, I have concluded that no radioactive material was used in the Interventional Radiology Room 1 located at 1000 Harrington Blvd., Mount Clemens, Michigan. The location of use is suitable for release to unrestricted use.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. NRC Region III office at (630) 829-9887 so that appropriate corrections and answers may be provided.

An environmental assessment for this action is not required because this action is categorically excluded under [Title 10 of the Code of Federal Regulations \(10 CFR\) Section 51.22\(c\)](#).

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This

could include issuance of a notice of violation; or imposition of a civil penalty; or an Order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy.
