This refers to your license amendment request dated January 30, 2024. Please find enclosed Amendment No. 39 adding Sheri Dawn Harrison, M.D. and Oren Nathaniel Jaspan, M.D. as authorized users of 10 CFR 35.100 and 35.200 materials. In addition, this action removes seven authorized users.

Please note that your correspondence, though submitted electronically, continues to identify the NRC Region I office at 2100 Renaissance Blvd, Suite 100, King of Prussia, PA. The Region I office completed a move in 2022 which resulted in the address shown at the top of this letter. An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
