Thank you for the expedited review. Even though we received a quote for a 50 mCi source, Vega came back with this e-mail after we sent them the license renewal:

Hello Justin,

Thank you for sending over your amended license. After my review, there is a slight issue that will need to be corrected before we can authorize shipment of your equipment. For Section 8.E., your license has a maximum activity limit of 50 mCi to be loaded into a VEGA model SE82. The equipment you will be receiving will contain 70 mCi loaded into a VEGA model SE82. We must request that you have the activity limit increased to 70 mCi. I apologize for any inconvenience this will cost you but we must ensure we are only distributing material that will keep you in compliance. Please let me know if you have any questions or concerns. Once the corrected license has been received, please forward a copy for our review and records.
