
To Whom It May Concern,

This letter is an amendment request for Saint Francis Medical Center's (SFMC) NRC license, 24-00158-03. We wish to make the following changes to the license:

1. To amend the use of TheraSphere and SIR-Spheres Yttrium-90, permitted by 10 CFR 35.1000, to "in storage only" as a tiered approach to closing the Y-90 microsphere program. SFMC will no longer order, receive, or administer any Y-90 microspheres but possesses Y-90 microsphere waste. Once all the Y-90 waste is disposed of, another amendment request will be submitted to completely remove Y-90 microspheres, both TheraSphere and SIR-Spheres, from the license.
2. To make the following changes to the Authorized Users and their associated uses:
 - a. Remove 10 CFR 35.1000 TheraSphere and SIR-Sphere from the materials and uses for Tom B. Brummit, D.O. and Todd Michael Buersmeyer, M.D.
 - b. Remove Patrick M. Keating, M.D. from the license as he no longer works at SFMC.
 - c. Remove Venkatesh Arumugam Murugan, M.D. from the license, as he will leave SFMC in the next 30 days.
 - d. Remove 10 CFR 35.500 Use of Sealed Sources and Medical Devices for Diagnosis from the material and uses for Mark Lewis Pfautsch, D.O.
Part 500 was removed from the license with the amendment request dated June 29, 2023 (ML23180A238).
