Enclosed is Amendment No. 70 renewing your NRC Materials License No. 13-12371-01, in accordance with your request dated February 7, 2024.

In addition, you requested in your letter dated May 9, 2024, that one of the locations of use on your license be decommissioned and released. You provided a facility decommissioning report to support your request. The NRC staff has reviewed all of this information, including the final status surveys. Based on its review, the staff has concluded that all licensable radioactive material has been removed from 313 Federal Drive NW, Suite 20, Corydon, Indiana 47112, and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Therefore, you may release this location for unrestricted use.

Please review the enclosed documents carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U. S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
