This refers to your license amendment request dated May 28, 2024. Please find enclosed Amendment No. 12 authorizing Brett Nickell as the Radiation Safety Officer and materials user and updating the management contact for the license. The NRC Form 313 you provided identified the licensing action as a "renewal," instead of an "amendment." As you requested in your letter, the license expiration date, September 30, 2024, has been extended five years to September 30, 2029, in accordance with NRC policy.

An environmental assessment for this action was not required since this action is categorically excluded under 10 CFR 51.22(c)(14)(v).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC.
