This refers to your license amendment request dated May 29, 2024. Please find enclosed Amendment No. 25 authorizing the addition of three authorized users. Additionally, while not noted on your license, we have recognized the change in senior management contact and noted the recognition of your radiation safety officer's (RSO) authority to make legally binding commitments as they pertain to the NRC license. Additionally, license condition 12 was corrected to include the proper heading.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
