

Karr Tuttle Campbell is acting as legal counsel to Heritage Imaging Holdings LLC, a Delaware limited liability company (“**Heritage**”), in connection with Heritage’s planned acquisition (the “**Acquisition**”) of Front Range Mobile Imaging Inc., a Wyoming corporation (“**FRMI**”). This memorandum is provided in support of FRMI’s request for NRC’s prior written consent to transfer control of its existing NRC Radioactive Materials License, Number 49-29310-01, to Heritage in conjunction with the Acquisition. Details of the Acquisition are as follows:

- The acquisition will be structured as a “stock” purchase, whereby Heritage will acquire 100% of the equity interests of FRMI from the current shareholders of FRMI, Lyle Johnson and John Mastin.
- Prior to the acquisition, FRMI will convert, pursuant to Wyoming statute, from a corporation to a limited liability company.
- Following the Acquisition, FRMI will maintain its existence as a separate entity (a Wyoming LLC); the only change will be with respect to ownership.
- Following the Acquisition, John Mastin, FRMI’s current Radiation Safety Officer, will continue in the role of Radiation Safety Officer and will serve as President of FRMI.
- Following the acquisition, FRMI will be a wholly owned subsidiary of Heritage, which currently owns and operates two other companies, Heritage Imaging LLC (a Delaware limited liability company) and Shared Medical Technology, LLC (a Delaware limited liability company) that are engaged in the same business as FRMI, mobile medical imaging and nuclear medicine, throughout the Mountain West and upper Midwest (please refer to the attached organization chart of Heritage and its subsidiaries).
- The Chief Executive Officer of Heritage is Steve Coppess, M.D.
- The target closing date of the Acquisition, pending the necessary approvals, is July 31, 2024.

**Change of Control and/or Change of Ownership  
(Includes Change of Name)**

10 CFR 30.34(b) states that “no license issued or granted pursuant to the regulations...nor any right under a license shall be transferred, assigned or in any manner disposed of, either voluntarily or involuntarily, directly or indirectly, through transfer of control of any license to any person, unless the Commission shall...find that the transfer is in accordance with the provisions of the Act and shall give its consent in writing. Although not specifically addressed by 10 CFR 30.34, licensees undergoing a name change may also be affected by this regulation.

Control over licensed activities can be construed as the authority to decide when and how a license (licensed material and/or activities) will be used. A change of ownership may be an example of a change of control. The central issue is whether the authority over the license has changed. In all cases, determining whether a change of control has taken place or whether a change is in name only is the Commission’s responsibility.

Licensees must notify the Commission when they are undergoing a possible change of control and/or a change of name. While this notification is not required within a certain time frame, NRC needs adequate time to review the submittal to ensure that the transfer is in accordance with the regulations.

**Definitions:**

**Control:** Control of a license is in the hands of the person or persons who are empowered to decide when and how that license will be used. That control is to be found in the person or persons who, because of ownership or authority explicitly delegated by the owners, possess the power to determine corporate policy and, thus, the direction of the activities under the license.

**Transferee:** A transferee is an entity that proposes to purchase or otherwise gain control of an NRC-licensed operation.

**Transferor:** A transferor is an NRC licensee selling or otherwise giving up control of a licensed operation.

**Information Needed for Transfer of Control**

Licensees must provide full information and obtain NRC's **prior written consent** before transferring control of the license. Lyle Johnson owns 80% of FRMI. I, John Mastin, own 20%. Lyle is selling 100% of his shares to Heritage Imaging. I am retaining a portion of my shares, but it's unclear what percentage currently. However, I am and will continue to be a minority shareholder. Heritage Imaging will become majority shareholder. FRMI is not undergoing a name or EIN change. I am, and will continue to be, COO, RSO, and operating manager. All Radiation Safety Program P&P, and all other P&P and personnel will be unchanged and remain in full effect moving forward. There will be no name, address, or contact information changing. This is solely a majority vested interest change. The new partners have not intent of changing the operations or personnel of FRMI.**
2. Describe any changes in personnel or duties that relate to the licensed program. Include

- training and experience for new personnel and any changes in the training program. **There will be no changes pertaining to this section.**
3. Describe any changes in the location, facilities, equipment, radiation safety program, use, possession, waste management, or other procedures that relate to the licensed program. **There will be no changes pertaining to this section.**
  4. Describe the status of the licensee's facilities, equipment, and radiation safety program, including any known contamination and whether decontamination will occur prior to transfer. Include the status of calibrations, leak tests, area surveys, wipe tests, training, quality control, and related records. **All items pertaining to this section are in good-standing in accord with our normal and ongoing operations per NRC guidelines.**
  5. If current decommissioning funding plans (DFP) will be changed as a result of the transfer, the revised DFP should be submitted. If other financial assurance documents will be changed as a result of the transfer, confirm that all financial assurance instruments associated with the license will be held in the transferee's name before the license is transferred, and as required by 10 CFR 30.35(f), the licensee must, within 30 days, submit financial instruments reflecting such changes. **There will be no changes pertaining to this section.**
  6. Confirm that all records concerning the safe and effective decommissioning of the facility will be transferred to the transferee or to NRC, as appropriate. These records include documentation of surveys of ambient radiation levels and fixed and/or removable contamination, including methods and sensitivity. **There will be no changes pertaining to this section. Nothing is being decommissioned.**
  7. Confirm that both transferor and transferee agree to transferring control of the licensed material and activity, and the conditions of transfer, and that the transferee has been made aware of any open inspection items and its responsibility for possible resulting enforcement actions. **Both transferor and transferee are in agreement of the transfer. I am the operating vested partner, COO, and RSO for the current company and will be for the new entity.**
  8. Confirm that the transferee will abide by all constraints, conditions, requirements, representations, and commitments of the transferor or that the transferee will submit a complete description of the proposed licensed program. **Operationally and compliance wise, I am the transferor and transferee and will abide by all constraints, conditions, requirements, representations, and commitments of FRMI's NRC RAM license.**
  9. The transferee, in the case of fuel cycle facilities, shall provide documentation showing that it is financially qualified to conduct normal operations. The information can be in the form of income statements and balance sheet forecasts. **FRMI does not have fuel cycle facilities.**
