Enclosed is Amendment No. 69 to your NRC Materials License No. 21-08317-01 in accordance with your request dated May 29, 2024.

Please review the enclosed documents carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U. S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Please note that actinium-225 use was not added to the license as requested as this use falls under 10 CFR 35.300 already listed on your license and is covered by the existing possession limit. Also, related to this, Condition 16 was added to your license as a limiting condition in case you use any actinium-225 that contains an impurity of actinium-227 that can trigger the need for financial assurance due to its very low threshold.

In addition, in the aforementioned letter dated May 29, 2024, you requested removal of iodine-125 and palladium-103 sealed source usage at two of the locations of use on your license (Cadillac and Grayling, Michigan). We have removed those authorizations. Other authorizations for use of licensed materials remain in effect at those locations. However, you may release any areas at those locations where only iodine-125 and/or palladium-103 sealed sources were used for unrestricted use.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
