Because this is a request by a member of the news media for information of public interest, made in my capacity as an investigative columnist for the Daily Signal (a major news outlet), I actively gather information of potential interest to my audience, and I use my editorial skills to turn raw materials into a distinct work, and I distribute that work to my audience through articles.
