Explanation

This request is primarily and fundamentally for non-commercial purposes. As an investigative journalist and columnist, the requested information is in the public interest because of the innate lack of transparency of government agencies in disclosing information of national interest. Further, this is amplified by the slow processing times and understaffing of the agency's FOIA office, delaying timely release of information by the agency—impeding the ability to inform the public concerning actual or alleged Federal government activity; quickly creating circumstances, 'in which there exists possible questions about the integrity of the government that affect public confidence'. Because this is a request by a member of the news media for information of public interest, made in my capacity as an investigative columnist for the Daily Signal (a major news outlet), I actively gather information of potential interest to my audience, and I use my editorial skills to turn raw materials into a distinct work, and I distribute that work to my audience through articles.
