Office of Nuclear Reactor Regulation (NRR) and Office of Nuclear Material Safety and Safeguards Met with Energy Northwest (EN) to Discuss their Plans to License 12 Xe-100 Units on the Hanford Reservation Adjacent to Columbia Generating Station

On August 9, 2024, Office of Nuclear Reactor Regulation (NRR) and Office of Nuclear Material Safety and Safeguards met with Energy Northwest (EN) to discuss their plans to license 12 Xe-100 units on the Hanford Reservation adjacent to Columbia Generating Station (site of the cancelled WNP-1 and WNP-4). EN intends to submit a construction permit application by mid-2026, with operation of the first four Xe-100 units targeted for mid-2031. This project is anticipated to be a "fast follower" of the Dow – Xe-100 Project Long Mott.

# NRR Held a Public Meeting to Discuss the Draft Reactor Accident Analysis Modernization (RAAM) Report

On August 14, 2024, the staff held a public meeting to discuss the Draft Reactor Accident Analysis Modernization (RAAM) report (Agencywide Documents Access and Management System (ADAMS) Accession No. ML24213A123), which identified eleven areas where reactor accident analysis for new and operating light-water reactors has the potential to be simplified, streamlined or improved, while maintaining appropriate conservatisms. A significant percentage of the 100+ participants were public stakeholders, and several shared their perspectives on the selected topics and the potential impact to the industry. The staff will use the feedback gathered during the meeting to finalize the RAAM Report, including recommendations for which items to pursue.

## <u>Unified Agenda of Federal Regulatory and Deregulatory Actions: Semiannual Regulatory Agenda; 10 CFR Chapter I [NRC-2024-0059]</u>

On August 16, 2024, the U.S. Nuclear Regulatory Commission (NRC) published in the *Federal Register* (89 FR 66970) the semiannual regulatory agenda (the Agenda) in accordance with Public Law 96-354, "The Regulatory Flexibility Act," and Executive Order 12866, "Regulatory Planning and Review." The NRC's Agenda is a compilation of all rulemaking activities on which we have recently completed action or have proposed or are considering action. Comments are requested by September 16, 2024.

## Renewing Nuclear Power Plant Operating Licenses-Environmental Review; Final Rule; Correction; 10 CFR Part 51 [NRC-2018-0296; RIN 3150-AK32]

On August 13, 2024, the NRC published a notice in the *Federal Register* (89 FR 65755) correcting a final rule that was published in the *Federal Register* on August 6, 2024 (89 FR 64166), amending its environmental protection regulations by updating the Commission's 2013 findings on the environmental effect of renewing the operating license of a nuclear power plant. This action is necessary to correct formatting errors. The correction is effective on September 5, 2024.
