This refers to your license amendment request dated May 31, 2024. Please find enclosed Amendment No. 32 authorizing the possession and use of radioactive material under 10 CFR 35.300, as well as an associated authorized user, Michael E. Galloway, M.D. In addition, two modifications were made to your license concerning the format for the physical address of the licensed facility and a correction to the NRC's ADAMS Accession Number for a referenced document found in License Condition 14.B.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC.
