The purpose of this letter is to confirm the final arrangements for the upcoming operator licensing examination at H. B. Robinson Nuclear Power Plant.

The U.S. Nuclear Regulatory Commission (NRC) has approved the subject examinations, and you may administer the written examination in accordance with Revision 12 to NUREG-1021, "Operator Licensing Examination Standards for Power Reactors," during the week of September 16, 2024. The NRC staff will administer the operating tests during the week of September 9, 2024. The list of the applicants approved to take the examination has been provided to your office. The examination has undergone extensive review by my staff and representatives responsible for licensed operator training at your facility. Based on this review, I have concluded that the examination meets the guidelines of NUREG-1021 for content, operational, and discrimination validity. By administering this examination, you also agree that it meets NUREG-1021 guidelines and is appropriate for measuring the qualifications of licensed operator applicants at your facility.
