This refers to your license amendment request dated June 11, 2024. Please find enclosed Amendment No. 34 removing three authorized users and adding five authorized users to the license. As per email from Mark Perna dated August 20, 2024, all authorized users were added for 10 CFR 35.100 and 35.200.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
