Dear Members of the Technical Specifications Task Force:

The proposed changes would revise the TS based on Technical Specifications Task Force (TSTF) Traveler TSTF-592, Revision 2, "Revise Automatic Depressurization System (ADS) Instrumentation Requirements" (TSTF-592) (Agencywide Documents Access and Management System (ADAMS) Accession No. ML23256A352), correction letter (ML23283A002), and the associated NRC staff safety evaluation (SE) of Traveler TSTF-592 (ML24029A148).

By letter dated September 13, 2023, and correction letter dated October 10, 2023, (Agencywide Documents Access and Management System (ADAMS) Accession Nos. ML23256A352 and ML23283A002, respectively), the Technical Specifications Task Force submitted Traveler TSTF-592, Revision 2, "Revise Automatic Depressurization System (ADS) Instrumentation Requirements," to the U.S. Nuclear Regulatory Commission (NRC) as part of the consolidated line item improvement process (CLIP). Traveler TSTF-592, Revision 2, was approved as a CLIP traveler on January 31, 2023 (ML24029A148). The NRC staff's final model safety evaluation is enclosed.
