This refers to your license amendment request dated August 22, 2024. Please find enclosed Amendment No. 3 authorizing the requested change in a licensed location's suite number. Please note, as requested, that no actual change in licensed location occurred; this change is to correct a historical error associated with the assignment of suite numbers.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
