Dear Ms. Bell:

Enclosed is a corrected copy to Amendment No. 114 to your U.S. Nuclear Regulatory Commission (NRC) Materials License No. 13-06009-01, following receipt of the letter dated August 30, 2024, signed by Derek McMichael, PharmD, MBA, Vice President, Hospital Administrator, and Vice President, Network Medical Imaging, and your e-mail dated September 10, 2024, identifying apparent errors and omissions in Condition 10 and Condition 12.B. of your license.

Following a review, Condition 10.A., has been corrected to now add reference to Items 6, 7, 8 and 9, Part E, and the additional locations of use were added to Condition 10.G. Further, the requested Authorized Users have been reinstated in Condition 12.B.

An environmental assessment for this action was not required, since this action is categorically excluded under [Title 10 of the Code of Federal Regulations \(10 CFR\) §51.22\(c\)\(14\)](#).

Please be advised that your license expires at the end of the day in the month and year stated in the license. Until your license has been terminated, you must conduct your program in accordance with the conditions of your license, representations made in your license application, and NRC regulations. In particular, note that you must:

1. Operate in accordance with NRC regulations [10 CFR Part 19, "Notices, Instructions and Reports to Workers: Inspections and Investigations,"](#) [10 CFR Part 20, "Standards for Protection Against Radiation,"](#) [10 CFR Part 30, "Rules of General Applicability to Domestic Licensing of Byproduct Material,"](#) [10 CFR Part 35, "Medical Use of Byproduct Material,"](#) and other appropriate regulations.
2. Notify NRC in writing 30 days in advanced of any change in mailing address.
3. In accordance with [10 CFR §30.36\(d\)](#), notify the U.S. NRC promptly, in writing, within 60 days and request termination of the license:
 - a. When you decide to terminate all activities involving materials authorized under the license whether at the entire site or any separate building or outdoor area;
 - b. If you decide not to acquire or possess and use authorized material; or

When separated from this cover letter this letter is uncontrolled.

- c. When no principal activities under the license have been conducted for a period of 24 months.
4. In accordance with [10 CFR §35.14](#), notify the U.S. NRC no later than 30 days after:
 - a. The date that the licensee permits an individual to work as an authorized user, an authorized nuclear pharmacist, or an authorized medical physicist under [10 CFR §35.13\(b\)\(1\) through 35.13\(b\)\(4\)](#);
 - b. An authorized user, an authorized nuclear pharmacist, a Radiation Safety Officer, or an authorized medical physicist permanently discontinues duties under the license or has a name change;
 - c. The licensee's name changes but the name change does not constitute a transfer of control of the license as described in [10 CFR §30.34\(b\)](#); or
 - d. The licensee has added to or changed the areas of use identified in the application or on the license where byproduct material is used in accordance with either [10 CFR §35.100](#) or [§35.200](#).
5. Request and obtain a license amendment before you:
 - a. Change Radiation Safety Officers;
 - b. Order byproduct material in excess of the amount, or radionuclide, or form different than authorized on the license;
 - c. Add or change the areas of use or address or addresses of use identified in the license application or on the license (except for areas of use where byproduct material is used only in accordance with either [10 CFR §35.100](#) or [§35.200](#)) or
 - d. Change the name or ownership of your organization.
6. Submit a complete renewal application or termination request at least 30 days before the expiration date of your license. You will receive a reminder notice approximately 60 days before the expiration date. Possession of byproduct material after your license expires is a violation of NRC regulations.

When submitting future license amendments, please have the document signed by a management representative rather than the Radiation Safety Officer. The NRC views a letter signed by a management representative as indication that management has reviewed the application and concurs in the statements and representations contained therein. In addition, please note that NRC Form 313 requires the applicant, by signature, to verify that the applicant understands that all statements contained in the application are true and correct to the best of the applicant's knowledge. The signatory for the application should be the licensee or a certifying official of the licensee rather than a consultant.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking your license as specified in the NRC Enforcement Policy.
