

Office of Nuclear Reactor Regulation (NRR) Released a Draft White Paper on “Nth-of-a-Kind Micro-Reactor Licensing and Deployment Considerations”

On September 27, 2024, Office of Nuclear Reactor Regulation (NRR) released a draft white paper on “Nth-of-a-Kind Micro-Reactor Licensing and Deployment Considerations” ([ML24270A206](#)), which discusses strategies to enhance regulatory clarity, reliability, and efficiency of licensing nth-of-a-kind micro-reactors (and potentially other technologies), considering rising stakeholder interest in rapid, high volume deployment. The draft white paper will support planned engagement with the Advisory Committee on Reactor Safeguards and a separate public meeting with stakeholders in October 2024, which will inform the final development of a related notation vote paper.

NRR Met with Representatives from the Department of the Navy to Discuss Their Plans to Lease Land for New Nuclear Reactors to Power Domestic Navy Bases and the Surrounding Communities

On September 30, 2024, NRR met with representatives from the Department of the Navy’s Office of the Energy, Installations, and the Environment to discuss their plans to lease land for new nuclear reactors to power domestic Navy bases and the surrounding communities. This was an initial introductory meeting, with additional interactions scheduled in the near future to discuss and define the U.S. Nuclear Regulatory Commission’s (NRC)’s role in licensing new nuclear power plants.

Public Meeting to Seek Input on Advanced Methods of Manufacturing and Construction for Nuclear Energy Projects Per ADVANCE Act of 2024, Section 401

On September 30, 2024, staff conducted a virtual public meeting to seek input from external stakeholders as it prepares a report to Congress on advanced methods of manufacturing and construction for nuclear energy projects per ADVANCE Act of 2024, Section 401. Approximately 90 participants, including representatives from many of the external stakeholder groups specified in the ADVANCE Act, provided comments and feedback for the NRC staff to consider in its report. The staff received specific insights on considerations for deployment of new nuclear energy technologies with smaller units in a higher-volume production paradigm as it relates to our examination of rapid improvement or iterative innovations processes, to enable these future nuclear energy projects to benefit from innovation and lessons learned in real time. Other key topics discussed included participation in consensus standards activities, and qualification of new materials for high temperature reactors.

Shepherd Power LLC Submitted Its Initial Regulatory Engagement Plan

On October 1, 2024, Shepherd Power LLC submitted its initial Regulatory Engagement Plan (REP). The REP describes Shepherd Power’s commercial structure and deployment model, the NRC advanced reactor policy initiatives Shepherd Power is closely monitoring, near-term regulatory engagement activities, and future regulatory activities with a goal of submitting a COL application in early 2027 and deploying advanced microreactors by 2030.

Oklo Submitted an Updated Licensing Project Plan

On September 27, 2024, Oklo submitted an updated Licensing Project Plan (LPP) describing its pre-application engagements for a future fuel recycling facility application (ML24271A183). The LPP provides an updated schedule for future engagements, including their timing for future meetings and planned white paper submittals, continuing through calendar year 2025. Oklo did not make any changes to the anticipated schedule for submitting its application.

Electric Distribution, Transmission, Supply and Energy Management Services for U.S. Nuclear Regulatory Commission (NRC) Headquarters

On September 27, 2024, contract number 47PA0420D0064/31310024F0159 was awarded to Potomac Electric Power Company in Washington, DC. The purpose of this contract is to obtain electric distribution, transmission, supply and energy management services for U.S. Nuclear Regulatory Commission (NRC) Headquarters and the warehouse. The period of performance is from December 1, 2024, through November 30, 2029, with no option periods. The total potential value of the contract can be up to \$10,037,049.82.

NRC Public Site Content Management System Services

On September 27, 2024, contract number 31310024A0002 was awarded to Riva Solutions Inc. in McLean, VA. The purpose of this contract is to procure a broad range of content management system services for NRC's public-facing website. The period of performance is from September 27, 2024, through September 26, 2029, with no option periods. The total potential value of the contract can be up to \$5,500,000.

Systems Engineering Based Assessment Approaches for Digital Reactor Protection Systems

On September 30, 2024, contract number 31310024C0032 was awarded to Galois, Inc. in Portland, OR. The purpose of this contract is to identify areas in review guidance for digital instrumentation and controls where a modern systems engineering approach could support the migration of NRC's current regulatory review practice towards a risk-informed, performance-based practice and improve the effectiveness and efficiency of licensing reviews. The period of performance is from September 30, 2024, through October 29, 2025, with two option periods. The total potential value of the contract can be up to \$727,008.

Acquisition Management System

On September 27, 2024, contract number 47QTCA19D00EP/31310024F0160 was awarded to Unison Software Inc. in Dulles, VA. The purpose of this contract is to provide, implement, and host a commercial item acquisition management solution, including help desk and training services, that fully integrates with NRC's financial system. The period of performance is from June 1, 2025, through May 31, 2027, with eight option periods. The total potential value of this contract can be up to \$34,783,555.77.
