The NRC is preparing to terminate American Centrifuge Operating's (ACO's) license SNM-7003 for the American Centrifuge Lead Cascade Facility in Piketon, Ohio. ACO's request to terminate the license, dated November 2, 2023, is here: ML23311A313. In addition, ACO submitted form 314, "Certificate of Disposition of Materials" (ML24135A205). The information included with this certification describes ACO's April 2018 final status survey report, the NRC's May 2018 confirmatory survey, and the NRC's follow-up onsite inspection.
