The NRC has reviewed your June 6, 2024 letter requesting to list Diane Haseman as the Radiation Safety Officer (RSO) on Corteva Agriscience, LLC's (your) U.S. Nuclear Regulatory Commission (NRC) Materials License No. 13-26398-01. Additional information is needed to complete our review. If the requested additional information cannot be provided within 14 days of this message, please let us know the date by which such information can be provided as soon as possible. ## ADDITIONAL INFORMATION NEEDED TO COMPLETE OUR REVIEW:

## **RADIATION SAFETY OFFICER MEMORANDUM OF UNDERSTANDING:**

The request to add the new Radiation Safety Officer included a Delegation of Authority Memorandum signed by your Executive Vice President, Chief Technology and Digital Officer, as well as a list of RSO Duties and Responsibilities. However, the request was incomplete in that it was not signed by the proposed by the proposed RSO, and so was inconsistent with the following:

- A Memorandum of Understanding and Delegation of Authority that contains the elements in NUREG 1556, Vol 11, Rev. 1, Appendix D, p. D-1 to which the NRC would find acceptable, needs to be signed by the proposed RSO as well as your management.
- The Delegation of Authority that was submitted for the RSO listed on Amendment No. 34 to your license, via application dated August 18, 2021 (ML21230A301) includes the signatures of RSO Kenneth Beavers and Management.
- The Renewal Application dated June 28, 2019 (ML19182A028) included commitments that, among others, the RSO should be willing to perform the functions required to be RSO.

To assure that the proposed RSO understands the duties, and is willing to perform the functions required to be RSO, please provide an updated Memorandum of Understanding and Delegation of Authority signed by both the proposed RSO and the Licensee's management, in accordance with the license, past applications, and NRC guidance.

Please provide the additional requested information as a signed and dated letter, as a pdf file attached to an email, on or before October 10, 2024. If you have any questions regarding this request, or if you need additional time to respond, please do not hesitate to reach out to me via phone or email.
