Dear Santosh K. Kar:

This correspondence refers to your license amendment requests dated August 6, 2024, and September 6, 2024. Please find enclosed Amendment No. 122 to your U.S. Nuclear Regulatory Commission (NRC) Material License No. 13-15882-01 for The Community Hospital. Please note that we did not list the Americium-241 sources on your license at this time. This request will be addressed separately.

Please review the enclosed document carefully and be sure that you understand all conditions. An environmental assessment for this action was not required because this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (CFR) 51.22(c).

In your letters dated August 6, 2024, and September 6, 2024, you described the use of material and provided the close-out survey results for Camera Room 1, located at 801 MacArthur Blvd., Munster, Indiana, Suite 201. You also confirmed that all residual licensed material used in this room had been removed – such that any remaining residual radioactivity is within the limits of Title 10 CFR Part 20, Subpart E.

Based on its review of close-out survey information, the staff has concluded that all licensable radioactive material has been removed from Camera Room 1 and residual radioactive material attributable to licensed activities in this room does not exceed current NRC criteria. Based on these conclusions no further remediation or action with respect to NRC regulated material is required. The Camera Room 1, located at 801 MacArthur Blvd., Munster, Indiana, Suite 201, is suitable for unrestricted use.

You will be periodically inspected by the NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action(s) against you. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking your license as specified in the NRC Enforcement Policy.
