I asked him for the sealed source information (isotope, activity, calibration, etc) for the sources in storage and plans for storage and disposal. For now, we will list them as storage only on the license. You will need to submit an amendment once the sources are no longer in your possession so that we may remove 35.500 entirely from your license.

He said that the GD.LIN2 source is no longer in your possession. In order to remove it from your license, please also provide the leak test and disposal information for that source.

To my understanding after speaking with him, the move has already taken place and the 3<sup>rd</sup> floor is ready for decommissioning. It was my understanding prior to speaking with him that the move will take place after the renewal. Please let me know when the new area went into use and also if there have there been any activities under 10 CFR 35.300 or PET performed at the new facility since the move.
