Upon receipt of your request, we tasked the Office of Nuclear Material Safety and Standards (NMSS) in NRC's
neadquarters, and Region IV (RIV), given the site's location near San Diego, California, to search for the reports that were
produced for each of the four phases of decommissioning you noted in your request.

NMSS staff located no responsive records. RIV staff informed us that the General Atomics site is Docket No. 070-00734. RIV staff identified the four reports, all of which are already publicly available in NRC's official record repository, ADAMS.
