Dear Dr. Tam:

This is in reference to your letter dated November 5, 2024, responding to the first request for additional information. Please be aware that all "Item", "Section", and "Appendix" references below are referring to NUREG-1556, Volume 9, Revision 3, "Consolidated Guidance About Materials Licenses: Program-Specific Guidance About Medical Use Licenses" found at <https://www.nrc.gov/docs/ML1925/ML19256C219.pdf>. In order to continue our review, we need the following additional information:

1. You provided the revised shielding recommendations for a relocation plan dated August 19, 2024. Please confirm that at least the minimum required lead shielding will be installed per the relocation plan. If possible, please confirm what actually will be installed and if it is different than the minimum required lead shielding.
2. From the shielding calculations, it is the NRC's understanding that the new uptake room/hot lab will not be used as the primary injection room based on the workload of three patients per week. Please confirm that this understanding is correct to ensure that the most conservative number is being used in the shielding calculations.

We will continue our review upon receipt of this information. Please reply to my attention at:
