Learning Objectives

Understand the Importance of a) good radiation safety practices when performing CT-guided interventional procedures and awareness of potential for high extremity exposure, and b) compliance with NRC occupational dose monitoring and training requirements.

Background

Post-inspection reactive extremity exposure monitoring resulted in discovery of high extremity exposure practices by an interventional radiologist. Inadequate educational training on occupational exposure limits and proper dose monitoring requirements is common practice at many facilities for physicians due to assumed knowledge based on credentials and experience.

Clinical Findings/Procedure Details

Extremity exposure monitoring of an interventional radiologist working at multiple facilities was initiated and annual exposure limits were quickly exceeded. Investigation determined this over-exposure was due to the physician performing CT-guided interventional procedures with the hand in or near the CT beam radiation field. A cumulative dose reconstruction estimated that the extremity exposure was likely between 2 and 5 Gy.

Conclusion and/or Teaching Points

Poor radiation safety practices can result in physician over-exposure. The facility occupational radiation worker training and dose monitor program must include physicians utilizing licensed and unlicensed source of radiation.
