This refers to your license amendment request dated January 24, 2025. Please find enclosed Amendment No. 32 listing Lauren Averill, M.D. as an authorized user for 10 CFR 35.100/200 uses, and removing Rahul Nikam, M.D. as an authorized user. Additionally, you will note that I have removed the listing of F-18 under Item 6.E. since its use was listed as "For human research under the provisions of 10 CFR 35.6." The use of F-18 for clinical human use is permitted under 10 CFR 35.200 subject to the constraints of 10 CFR 35.6 by regulation and therefore does not require a separate line item on the license.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC.
