Dear Sir or Madam:

In accordance with 10 CFR 50.54(p), Vermont Yankee Nuclear Power Station (VY) hereby submits the ISFSI Physical Security Plan, Revision 1.

This change to the Independent Spent Fuel Storage Installation (ISFSI) Physical Security Plan, Revision 1 reflects recent changes to the 10 CFR 73 reporting requirements. Specifically, notifications to the NRC will be made in accordance with the reporting requirements of 10 CFR 73.1200 Notification of Physical Security Events (vs. the previous 10 CFR 73.51) and 73.1205 Written Follow-up Reports of Physical Security Events (vs. to previous 10 CFR 73.71 and 10 CFR 73, Appendix G). In addition, this revision includes an updated Figure 3-2 identifying a modification to the vehicle barrier block configuration.

An evaluation of this Physical Security Plan revision in accordance with 10 CFR 50.54(p)(2) has determined that the incorporated changes do not reduce the effectiveness of the plan and that the plan continues to meet the standards of 10 CFR 72.212(b)(9).

This letter includes two enclosures. Enclosure 1 contains a Summary Description of Changes. Enclosure 2 is Safeguards Information as defined in 10 CFR 73.2 and contains a copy of the VY ISFSI Physical Security Plan, Revision 1.
