Dear David Rhoades:

The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2024-009) on February 2, 2024, to determine whether a Senior Radiation Protection Technical Support Specialist (TSS) at Limerick Generating Station was discriminated against for having raised safety concerns. Based upon documentary and testimonial evidence developed during the OI investigation, the NRC did not substantiate that the TSS was discriminated against for having raised safety concerns.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA. Requests under the FOIA should be made in accordance with 10 CFR 9.23, Requests for Records.
