SUBJECT: ANNUAL REGISTRATION OF GENERALLY LICENSED DEVICES

The U.S. Nuclear Regulatory Commission (NRC) requires annual registration of certain devices that are possessed under the general license issued in Section 31.5 of Title 10 U.S. Code of Federal Regulations (10 CFR 31.5). Devices subject to registration include those containing the radioactive material and activity listed in Table 1 of the attached NRC Form 664.

**NOTE:** You are receiving this notice because NRC records indicate that you have one or more such devices, however, you did not return your completed registration for 2020 as required. The NRC realizes that mail delivery was not as efficient during the pandemic and mail may not have reached the intended recipient in 2020, therefore, we are resending your registration. The enclosed registration will cover both 2020 and 2021 annual registrations. If you no longer have the devices, please update your registration form so we can update our system.
